## **MINUTES**

## 1) CALL TO ORDER & ROLL CALL OF DIRECTORS

Chairman Grandi called the meeting to order at 4:01 PM

There were no public comments.

#### 3) REPORTS

#### A. Meter Technician Report - Jay Huebert

Huebert was unable to attend the meeting. The technician's report to the Directors summarized the pumping total for the latest water year (October 1, 2023 to September 30, 2024). Municipal pumping totaled 570 acre-feet and ag pumping totaled 7,813 acre-feet, for a combined total of 8,383 acre-feet.

# 4) **DISCUSSIONS/ACTIONS**

#### A. Plumas/Sierra County Well Permit Application Review (if any)

#### 1. Meadow Edge Park

David Shaw, President and principal hydrologist of Balance Hydrologics, presented the 8-hour pump test results from the Meadow Edge Park well evaluation he conducted. A comprehensive 8-hour pump test was conducted on Well 4 on October 16, 2024 and effects were monitored on nearby wells.

Let the minutes note Director Ceresola joined the meeting at 4:15 p.m.

Dwight Smith, Principal Hydrogeologist for UES, evaluated the pump test results with the Board. He believes the report followed SVGMD guidelines well and does not present any red flags considering nearby wells or SGMA goals. He made the recommendation to the Board that this one pump test is sufficient and Meadow Edge Park should not need to test pump their other three wells.

Director Goicoechea made a motion that conducting a pump test on one well at Meadow Edge Park is adequate and the other three wells will not require a pump test, Director Roen 2<sup>nd</sup>, motion passed. Directors Roberti, Grandi, Kilmurray, Goicoechea, Ramelli, Ceresola and Roen in favor.

#### **B. DWR Implementation Grant Amendment**

A draft amendment to the DWR grant agreement has been submitted to DWR for proposed language changes to Component 4: Irrigation Efficiency and Conjunctive Use. DWR is reviewing the proposed changes.

Director Goicoechea made a motion to approve the amendment as presented and authorized the Chairman to sign should DWR accept the changes, Director Roen 2<sup>nd</sup>, motion passed, all in favor.

#### C. Your H2O Pro Estimate - DMS 12 Flow Meter Replacement

Chairman Grandi spoke to the meter technician about this estimate prior to the meeting. Huebert explained that after flooding multiple times DMS 12 requires a major replacement.

Director Goicoechea made a motion to approve the Your H20 Pro estimate for DMS 12, Director Roen 2<sup>nd</sup>, motion passed, all in favor.
